## 2019 Dutch Christmas Hamper Fair Participation Terms and Conditions

These conditions for participation in the 2019 Dutch Christmas Hamper Fair are taken from the General Regulations, filed with the Chamber of Commerce and Industry in Eindhoven on 1 May 1996 under #4274/96, which apply to all transactions concluded with us. A free copy will be sent to you on request.

1. The registration form for participation (including the appendices) must be received by FairExpo B.V. (hereinafter referred to as FairExpo) by 25 January 2019.
2. Acceptance of registration is processed independently by FairExpo. FairExpo reserves the right to refuse participation. The allocation of stand spaces and the location of the stands is handled by FairExpo, which reserves the right to change and/or adjust the hall layout up to 5 days prior to the first day of the fair. A participant can never lay claim to a certain stand and/or stand location. FairExpo will not make any binding commitments.
3. Exhibitors who claimed a particular stand location upon registration and have failed to meet the conditions of payment lose the right to lay claim to this location.
4. The fair will take place on Tuesday, 5 February, and Wednesday, 6 February 2019. On both days, the fair will be open from 10 a.m. to 5 p.m. The exhibitors are required to have their stand fully furnished and ready for the fair by 9:30 a.m. on Tuesday, 5 February 2019 .
5. Setup of the exhibition by exhibitors with custom stands will take place on Monday, 4 February, 2019. Approximately 4 weeks prior to the start of the fair, exhibitors will receive instructions on when they can commence construction of their stands.
6. Custom stand builders must submit a drawing of their stand to FairExpo two weeks prior to the fair, in order to review whether their stand meets the requirements of the Fire Service and the Building Control Department.
7. Disassembly of the fair will take place on Wednesday, 6 February 2019, after the end of the fair. The fair hall will then be open until 10 p.m.
8. Subletting of the stand is not permitted unless this is done in consultation with, and with the permission of, FairExpo. If two companies wish to jointly present themselves at one stand, a minimum of 14 m<sup>2</sup> of stand space must be purchased.
9. A registration cannot be unilaterally changed or revoked by a participant. If a participant wishes to cancel their registration, a written, registered request must be made to FairExpo. The latter can grant a request for cancellation on condition that a cancellation fee is paid by the participant concerned. This fee is: 50% of the total rent including all facilities, after participation has been confirmed by FairExpo and in case of cancellation up to 1 January 2019, and 100% of the total rent including all facilities, after participation has been confirmed by FairExpo and in case of cancellation after 1 January 2019.
10. Invoicing:
  - a. Exhibitors who register before 1 August 2018 will take part in the pre-registration raffle. The 50% advance invoice will be sent on 2 August 2018.
  - b. If you register after 1 August 2018, the 50% advance invoice will be sent after participation has been approved and confirmed by the organization.
  - c. The exhibitor will receive the invoice for the remaining 50% in early January 2019;
  - d. Exhibitors who register after 1 December 2018 will receive an invoice for the total amount;
  - e. All invoices must be paid within 8 days of the invoice date.
11. Cancellation of fair participation within 72 hours prior to the start of the first day of the fair will be considered a "no show". In this case, a no-show fee of € 2,000.00 excluding VAT will be due.
12. If the participant has not paid the amounts owed by them within the stipulated deadlines, FairExpo will be entitled to revoke a registration and/or refuse to grant stand space, without prejudice to FairExpo's claim for compensation by the aforementioned amounts. The participants cannot claim any refunds in this case.
13. Each participant will be liable for, and must take out adequate insurance against, any damage and/or theft, and will indemnify FairExpo against any claims that others, in connection with their actions, could assert against FairExpo.
14. FairExpo reserves the right to give instructions to the participants in the fair or to take measures for purposes of Public Health and Fire Prevention or government measures and/or guidelines. The participants must comply with these instructions and/or adhere to the measures taken by FairExpo. Instructions and measures by FairExpo in this context can never constitute a reason to dissolve the agreement or to claim compensation.
15. In case of national mourning and/or as a result of other guidelines, orders or prohibitions issued by the government, FairExpo retains the irrevocable right to, at its own discretion, change the date of the fair or to cancel the fair altogether, without the exhibitor being able to terminate his contract or neglect their obligations to FairExpo.
16. FairExpo reserves the right, in the interest of the fair, to change, at their own discretion, the date of the fair, the fair location or the fair opening times (mentioned in artt. 4 and 5), without the exhibitor being able to terminate his contract or neglect their obligations to FairExpo.
17. FairExpo reserves the right, in the interest of the fair, to transfer the organization rights of the fair to another legal entity at their own discretion, without the exhibitor being able to terminate his contract or neglect their obligations to FairExpo.
18. By registering for participation in the 2019 Dutch Christmas Hamper Fair, the participants confirm that they have taken note of these participation conditions and agree to their contents. In all cases where these conditions deviate from the General Regulations of FairExpo, these conditions will apply.
19. In all cases that are ambiguous or are not covered by these conditions of participation, FairExpo will decide.
